episodes of dermatoses were seen in the study period. The vast majority of the patients were referred from the departments of general medicine. An analysis of the total number of dermatoses in a 5-year period suggests an increase in the incidence of dermatoses in the population studied. Three main groups of dermatoses were recorded: acute dermatoses, chronic dermatoses and inflammatory dermatoses. Acute dermatoses were seen in the age group of 12-30 years and chronic dermatoses in the age group of 31-40 years. Out of the total dermatoses, 15.6% were idiopathic and 26.3% were viral infections; the rest was divided into different types of allergic dermatoses, eczemas, scabies, fungal dermatoses and drug reactions. Scabies was seen to be increasingly common in every

5-year period of the study.Q:

So I'm trying to obtain a matrix with the following dimensions: Is there any problem with the struct declaration? A: When you use a literal array, you don't need to tell the compiler the size. It knows by default, and is called a "compile-time array". You can only define run-time arrays at all. If you have too few elements, the size is one short and a runtime error is raised. If you have too many elements, the size is too long and you get a segmentation fault. However, you can use a run-time array (by using `new`). A: You forgot the size, the runtime error is that you are trying

to allocate less then 0 elements in
your array.

The problem is that I cannot programmatically do that in an elegant way: try { //Do some code } catch(MyError e) { //I need to know that "catch" was triggered! How can I? } I need to know that the code was executed from the code that caused the error. I do not want to exit the method if it is within an try. What I mean is that I have a method, and I need to run that code to see if it is ok or not. If it has errors, then I need to print them to the Console. However, if the method "thinks" it is ok (which it cannot know), then it should

return some value to indicate this to the code that called the method, which in turn can continue execution. A: Maybe using a Resharper snippet in conjunction with R#6.1 - Resharper Snippet: Continues On Error could solve your issue? Resharper Snippets are snippets of codes that you can create and use. Also, the above snippet looks like the one that is generated by Resharper when you put the "continue on error" and "swallow" codes together.
